- THIRD PARTY PUBLIC LIABILITY FOR RS.50 LAKHS VALID DURING THE RUNNING OF THE EVENT ONLY.
- A MAXIMUM OF 100 OFFICIALS OFFICIATING &
- 150 COMPETITORS WITH VALID FMSCI COMPETITION LICENCE PARTICIPATING
