Arrive at Theog just ahead of Shimla and check-in to the Taj Theog Resort & Spa, where you can spend your day in luxury and leisure. You can even unwind amongst the cedar forests just before the adventure ahead. Interact with your fellow 'Journeyers' over a pre-drive briefing later that evening, followed by dinner.




After breakfast, we begin our 250 km journey to Manali across the Jalori Pass. Once in Manali, take a stroll around Mall Road. Sit on the banks of the Beas, and feel the cold, clear water gently wash over your feet. Manali has a lot to offer - traditional handicrafts, ancient and unique temples, local villages or monasteries. Return to the hotel, indulge in a sumptuous dinner and call it a night.




The 140 km drive to Jispa across the Rohtang Pass is picturesque, and breathtaking. Located at an elevation of 10 500 ft, this riverside village has a population of 332. The locale is peaceful and almost therapeutic, despite its proximity to the busy Leh-Manali highway. One look up, and your eyes will be treated to the mist-covered, postcard-worthy peaks.



Sarchu might be only 75 km away from Jispa, but the drive there will have you hoping that it never ends. The camp is located between Baralacha La to the south and Lachulung La to the north. We make our way to the Tsarap Chu river, the starting point for trekking in the Zaskar region of Ladakh. Enjoy a well-appointed tented experience for the night.



We begin our journey to Leh, bright and early. After a stopover for lunch, we reach this haven in the cold Himalayan desert. The beauty of Leh cannot be expressed in words. From the enigmatic gompas, a majestic palace, the lofty peaks, down to the deliciousness of the local momos - the plethora of attractions and experiences makes a visit to this city truly incomparable.



After a hearty breakfast, it's time to soothe your soul and ease your mind, as you get intoxicated by the wild beauty of your surroundings. Through the day, we visit monasteries and palaces, defy gravity at the magnetic hill, find peace at the Shanti Stupa, and end the day by visiting the Hall of Fame.



# ITINERARY

## DAY 6



Travelling 160 km further, we find ourselves by the banks of the Pangong lake. This lake is bereft of aquatic life and has very sparse vegetation. Nestled amongst high peaks, at an altitude of around 14 270 ft, the lake is 134 km long, and stretches from Eastern Ladakh to Tibet. The crystal-clear brackish waters of Pangong Lake often change shades between blue and green, depending on the position of the sun. The landscape is rough and dramatic, with the auburn of the land being juxtaposed by the blues and greens of the sky and the lake.



## DAY 7



Nubra valley is a three-armed valley located to the North-East of Ladakh valley. Our 165 km journey takes us along the Shyok river. The Nubra Valley was once on the trading route that connected eastern Tibet with Turkistan via the famous Karakoram Pass. Nubra is like a trip back in time, into a little known 'Shangri La'. With breathtaking views, unearthly beauty, and charmingly welcoming inhabitants, it is an unforgettable last stop on our journey.



# ACCOMMODATION



We start our journey from the 5 star comforts of the Taj Theog Resort & Spa (Trip Advisor Rating 5/5), a spanking new Taj property, 33 km from Shimla. It stands tall at the edge of a ridge among coniferous trees with a stunning 180° view of the Churdhar, the highest peak of the outer Himalayas. We move onwards to the WelcomHeritage Urvashi's Retreat, Manali (Trip Advisor Rating 5/5) – a soul-lifting getaway crafted as a boutique homestay with Katkhuni-styled cottages finely panelled with aromatic pinewood. Our next stay is on the banks of the Bhaga river in the Lahaul Valley at the Ibex Hotel, Jispa (Trip Advisor Rating 3.5/5) that is set amongst picturesque snow-capped mountains at a height of 10 890 ft. Our campsite stay will be at the Goldrop Camp at Sarchu

(Trip Advisor Rating 3.5/5) that offers deluxe tented accommodation with attached bathrooms. We will arrive into Leh at the only 5 star in the city – The Grand Dragon, Ladakh (Trip Advisor Rating 4.5/5) that is located close to the Leh Palace and market. Most rooms offer superb views of the snow-capped Stok Kangri mountain. Our stay on the shores of the Pangong Tso lake will be at one of the few built up properties there, the Ser Bhum Tso Resort (Trip Advisor Rating 3.5/5) at Spangmik, followed by a stay at the finest property in Nubra – the Stone Hedge Ladakh (Trip Advisor Rating 5/5) situated in the Hunder village. The last night of the journey will see us return to The Grand Dragon Ladakh at Leh.

# FREQUENTLY ASKED QUESTIONS

## Who Operates the Journeys?

Land Rover Journeys are operated by Cougar Motorsport Pvt. Ltd., who are licenced and authorised by Jaguar Land Rover India Ltd. When you make a booking you will enter into a contract with Cougar Motorsport.

## Who is eligible to participate?

Indian nationals with privately registered Land Rover vehicles are eligible to participate by completing the documentation and paying the registration fee. The Organisers may accept or reject any registration and participant at their discretion.

## Can children participate?

Children above 12 years of age can participate by paying the same registration charges as adults. There are no registration charges for children below 12 years of age provided they are accommodated in the same room as their parents or guardians. Any charges levied towards extra beds or meals will be payable directly by the parents or guardians at check-out.

## Who is eligible to drive?

All driving guests must be at least 19 years of age and have held a full valid driving licence for at least one year. No participant will be allowed to

drive under the influence of alcohol.

## Do I need any off-road driving experience?

Basic driving experience will suffice. There will be a qualified Land Rover Experience instructor accompanying each journey who will provide expert guidance and reassurance. Although, each journey is designed for drivers of all abilities.

## How many participants can be in each vehicle?

At the discretion of the participants subject to the vehicles carrying capacity for passengers and baggage.

## Do we travel in a convoy?

Yes, we will generally travel in a convoy.

## How many vehicles and guests will be accepted in the Journeys?

To maintain a more intimate and exclusive experience, the maximum group size of vehicles and guests for each journey will be 10 vehicles and 20 guests respectively. This may however be lower for select journeys due to logistical reasons including where accommodation options are limited.

## Do I need to purchase insurance to be able to participate?

We recommend a personal accident insurance in addition to a valid comprehensive insurance of your Land Rover vehicle.

## Do I need to have a certain level of physical fitness to take part?

To participate in the journey you should ensure that you do not know of any circumstances which would disqualify you from driving such as chronic back problems (or similar conditions), mental conditions which might impair your ability to drive, eyesight which doesn't meet the standards for driving, pregnancy or heart problems.

## What is included in the price of the journey?

General inclusions are as follows: convoy coordination and driving activities, twin sharing accommodation, breakfast, lunch & dinner, any permits and entry fees.

## What isn't included in the price of the journey?

Personal accident insurances, tips, all personal expenses (e.g. alcohol, minibar in the hotel, spa treatments etc.) and any pre or post-trip

arrangements that deviate from the itinerary.

## Is there a specific type of luggage I should bring?

We do not make any specific recommendations with regards to the type of luggage as long as your vehicle can accommodate the same.

## What is the dress code for evenings?

Evening dress code will be casual.

## What happens if a journey does not reach its minimum numbers? Will it be cancelled?

We endeavour not to cancel any of our journeys but in some cases this may be inevitable. We reserve the right to cancel a journey if minimum operating numbers have not been reached 4 weeks before departure.

## Are the itineraries and accommodation confirmed?

Your itinerary and accommodation are subject to change based on availability. We reserve the right to replace the itinerary and accommodation with similar alternatives.

breakfast, packed refreshments and dinner, permits & medical support, if any.

## Can arrangements be made for the transportation of my vehicle?

Charges for transportation of vehicles by truck will be available on request. All such services will be at the risk of the participants and the Organisers will not assume any responsibility for the same.

## What is the cancellation policy?

The charges paid will be refunded in case the registration is rejected by the Organisers or in case the journey is cancelled by the Organisers. The charges will NOT be refunded for ANY OTHER reason.

# TERMS AND CONDITIONS

<p><b>Organisers:</b></p> <p>- Jaguar Land Rover India Limited (JLRIL) has authorised Cougar Motorsport Pvt. Ltd. (Cougar Motorsport), to organise the Land Rover Journeys (Journey), and their related activities. Cougar Motorsport is authorised by JLRIL to receive payments from participants for the journey. Cougar Motorsport along with its shareholders, sponsors, affiliates, sub-contractors and suppliers and all of their respective officers, directors, employees, servants and agents are collectively referred to as the “Organisers”.</p> <p><b>Attendee:</b></p> <p>- The below mentioned Terms and Conditions govern the relationship between you, the participant of the Land Rover Journey, referred to as “Attendee” or “Client”, and the Organisers. By registering for the Journey and making a payment of the agreed amount to the Organisers, you agree to be bound by these Terms and Conditions.</p> <p><b>Third parties:</b></p> <p>- Although Cougar Motorsport is making the arrangements for the Journey, its responsibility is limited. Cougar Motorsport is involved in the bookings related to the Journey but does not act as an agent for any party whatsoever.</p>	<p>The limits of its responsibility arise from the fact that it liaises with independent third parties such as independent tour operators, hotel companies, transportation companies and/ or drivers and other ground operators and suppliers to supply goods and services to attendees; however, such third parties are not Cougar Motorsport’s employees or agents or employers or principals. Accordingly, each Attendee agrees that Cougar Motorsport shall not and shall be deemed not to manage, control or supervise the goods or services they supply and shall not be liable for any acts or omissions, including any negligence, gross negligence, or reckless or willful acts, on the part of such third parties or any other defect in such goods or services. By accepting and utilising the goods and/ or services of said third parties, each Attendee agrees that Cougar Motorsport shall not be held liable in any way for any injury, loss, damage, delay, or death or property loss or damage arising from any act or omission of any such third party. Attendees will be subject to the terms and conditions, if any, made applicable by such third-party suppliers.</p> <p>- Each Attendee further agrees that JLRIL shall not and shall be deemed</p>	<p>not to manage, control or supervise either the Organisers or the third party suppliers for the Journey and shall not be liable for any acts or omissions, including any negligence, gross negligence, or reckless or willful acts, on the part of the Organisers or such third parties or any other defect in the Journey or such goods or services. By participating in the Journey and accepting and utilising the goods and/ or services of said third parties, each Attendee agrees that JLRIL shall not be held liable in any way for any injury, loss, damage, delay, or death or property loss or damage arising from any act or omission of the Organisers or any such third party.</p> <p>- The Organisers have made best efforts to procure the best hotels available keeping the comfort and convenience of the Attendees as per the itinerary as priority and have been selected based on strong internal assessment.</p> <p>- While the Organisers will make efforts to ensure the delivery of services that are to be provided by the hotel, the Organisers act as a facilitator for the Attendee and the hotel and shall under no circumstance accept any responsibility for inadequate/deficient/negligent services provided by the hotel. The Organisers shall not accept any</p>	<p>complaints from the Attendee with respect to services provided by the hotels and that any grievance or complaint shall be directly lodged with the concerned hotel management.</p> <p>- The Attendee shall be liable to make good any damage(s) caused by any act of the Attendee (wilful/ negligent) to the property of the hotel in any manner provided by the hotel policy. The extent and the amount of the damage so caused will be as determined by the concerned hotel. The Organisers shall not intervene in the same in any way.</p> <p>- The menu for all meals will be pre-set as per the package.</p> <p>- The Organisers reserve the right to change the menu if circumstances necessitate such a change without any prior notice to the Attendee. If the Attendee does not avail the meals (as offered in the menu) for any reason, then no claim can be made for the unutilised meal against the Organisers.</p> <p><b>Itinerary:</b></p> <p>- The Organisers take all reasonable steps at the time of finalising the itinerary for the Attendee to ensure that the itinerary is as per the convenience and comfort of the Attendee. However, the Organisers reserve all the rights to effect any change in the itinerary due to any reason that the Organisers may deem</p>

fit for effecting such change and that the Organisers shall not be bound to take any prior permission or give prior notice to any Attendee before changing the itinerary. In the event of a change in the itinerary, the Organisers will inform the Client accordingly at the earliest possible time before the start of the Journey. JLRIL or the Organisers will not be responsible for expenses incurred by the Attendees in preparation for the Journey or for any other travel arrangements made by them.

- The Organisers can cancel the Journey in the event of not reaching the minimum number of participants as stipulated beforehand. In the event of such cancellation, the Organisers will inform the Client at the earliest possible time and at least one week before the start of the Journey and the Client shall be reimbursed immediately for any payment made against the price of the booked Journey. JLRIL or the Organisers will not be responsible for expenses incurred by the attendees in preparation for the Journey or for any other travel arrangements made by them.

- The Organisers will inform the Attendee in the event of any change in the itinerary of the Attendee post start of the Journey, which is beyond the control of the Organisers. A change to the itinerary will be made

considering all the factors that any prudent person will do from the Attendee’s convenience, safety and comfort perspective. JLRIL or the Organisers shall not accept any responsibility and shall not be held responsible in any manner whatsoever for any loss that an Attendee might suffer consequent to such a change.

- JLRIL or the Organisers shall not be responsible for any delay or alterations in the itinerary or expenses incurred - directly or indirectly - due to natural hazards, accidents, mechanical breakdowns, weather, sickness, landslides, political closures, prohibition orders, local unrest, traffic jams, medical emergency or any untoward incident. The Organisers reserve the right to claim any additional expenses because of delays or alterations in the itinerary, caused by any reason whatsoever.

- The Organisers reserve the right to, without prior notice, amend, alter, vary or withdraw any departure, excursion advertised, reverse the order of places to be visited or substitute a hotel of similar class if deemed advisable or necessary.

- In the event the Attendee misses out on any activity on the Journey due to delay on his part, the Organisers shall not be held liable to refund the money paid for the same or in any other manner whatsoever.

**Vehicles:**

- Attendees are required to bring their own privately registered Land Rover vehicle (“Vehicle”) for the Journey and ensure that the Vehicle has a valid comprehensive insurance coverage policy, is fit, serviced and technically ready for the Journey. Attendees shall also have to ensure that their Vehicles are driven by individuals with a full driving license for cars and having at least one year’s driving experience. Such driving license shall be carried in original during the Journey and be shown before the Journey begins.

- Attendees shall use the Vehicles, in adherence to the itinerary and route instructions of the Journey coordinator. They shall comply with and observe the road traffic regulations or the special regulations for the terrain driven on.

Any costs caused by the Attendee as a result of criminal offences / regulatory offences or the like shall be borne by the Attendee. The Attendee shall fasten her/his seat belt at all times in a moving vehicle and keep all windows closed whilst driving the car.

- It is the responsibility of the Attendee to check the condition of Vehicles at the beginning of the Journey. In the event of any breakdown of a vehicle during the journey that cannot be repaired, it is the responsibility of the Attendee

to arrange for an alternative vehicle. The Organisers will not be under any obligation to arrange for alternate vehicles or transportation for the Attendees to continue in the Journey and no request for refund of charges for the remaining Journey will be entertained. The Organisers will use their best efforts to arrange for a recovery vehicle to transport the Attendee’s Vehicle to the nearest point where repair facilities may be available. In such an event, the cost of the recovery vehicle will be borne by the Attendee.

- The safekeeping or the Attendees’ vehicles will remain the sole responsibility of the Attendees. Any damage caused to the Vehicle, during the journey because of accidents, negligence, natural causes shall be solely borne by the Attendee and JLRIL or the Organisers shall accept no claim and responsibility for any damages and/or expenses suffered by the Attendee/Vehicle.

- Fuel and toll charges would have to be borne by the Attendees for their own Vehicle.

- Attendees will have to strictly adhere to the prescribed timetable for the day so the Journey can be completed within the defined schedule. In case any of the sightseeing schedules are missed due to delays caused by the Attendee or for any other reason, the same shall not be refunded to the

Attendee under any circumstances.

**Conditions of Package:**

- The aforesaid conditions shall be applicable to every Attendee who books the package for the Journey with the Organisers.

- The Journey coordinators, particularly the driving instructors, shall be fully authorised to issue directives. All instructions shall be strictly followed, so that neither the Attendee himself nor other persons are harmed, and no property is damaged, as a result of the Attendee's conduct. Any actions of the Attendee in deviation to the Journey coordinator's instructions may expose him/her and others to potential dangers and the disobedient Attendee shall be held responsible for any loss, injury, damage caused to other Attendees. Breaches may lead to expulsion from the Journey.

- Attendees shall follow a strict no-alcohol-consumption policy while on the Journey. The Attendee shall be prohibited from driving a vehicle whilst under the influence of alcohol (zero-alcohol level), drugs or any other medicine or agents that impair her/his fitness to drive. In the event of any Attendee being found violating this rule, the Journey coordinator will have the authority to take any necessary action which they deem fit, in the interest of safety of the group.

- The Attendees shall follow the package itinerary. There shall be no refund, if the

Attendee fails to join the group at the appointed time of commencement of the Journey or join the group later or leave the group before the culmination of the Journey. Please note that for all purposes, it shall be the responsibility of the Attendee to reach the place of commencement of the Journey with their Vehicle and register with the representative of the Organisers at the appointed place on the given date and time.

- In case an Attendee along with her/his family is compelled to discontinue the Journey due to any reason whatsoever including illness, death or loss of any travel documents, no claim shall be entertained for refund of unutilised services. Further, the Attendee shall pay for any towing / transportation costs involved in moving the Vehicle. Even if a Client is unable to reach the place of commencement of the Journey due to any reason whatsoever including loss of baggage or loss of travel documents, his booking shall be treated as "no show" on the Journey and 100% cancellation charges will be levied.

- The Organisers reserve the right to withdraw participation of any Attendee whose behaviour is deemed likely to affect the smooth operation of the Journey or adversely affect the enjoyment or safety of other Attendees and the Organisers shall be under no liability to any such expelled Attendees.

**Health & Insurance:**

- The Journey that you have booked

is an adventure event that can place considerable demands on man and material. Driving on difficult terrain / in difficult track conditions may lead to extreme stress. Sand, dust, high humidity and unfavourable weather conditions etc. may impact upon you, your Vehicle and your personal equipment. Fundamentally, the Journeys are suitable only for fully fit, healthy, resilient adults.

- Each Attendee should only do what he feels capable of doing. Many activities involve risks. Each Attendee must decide himself what risk he wishes to take. If you are travelling as a legal guardian of an Attendee who is a minor, you need to be aware that you will be specifically responsible for assessing the risk and for making decisions on behalf of such Attendee.

- It shall be the duty of the Attendee to inform the Organisers in case the Attendee has any medical conditions, medical history or prescribed restrictions/ allergies that may affect his ability to enjoy and pursue fully the Journey and wherein the interest of the group or any member thereof is prejudicially affected.

- In the event that a medical condition has been disclosed, the Organisers shall make an effort to provide basic medical help within their means and the medical supplies and equipment available with them, subject to the Attendee continuing to remain with the convoy. The Organisers may take a decision to transport the Attendee to the nearest appropriate medical facility, using any

terrestrial or aerial means. Decisions will be based only on the medical aspect, the medical condition of the Attendee and the health regulations in force, either to hospitalise the participant in a nearby medical facility, before envisaging transport to the nearest hospital/facility at the nearest town. It is, in this regard, expressly stated that the final decision concerning the medical interests of the Attendee rest with the Organisers. In case where the Attendee refuses to follow the decision considered as the most appropriate by the Organisers, they discharge the Organisers of all responsibility, notably in cases where the Attendee arranges for her/his return by their own means or where the Attendee aggravates their own health. The Attendee shall therefore not make any claim to be refunded any expenses incurred. If the health of the Attendee causes, in the circumstances described above, the Organisers to decide to transfer them or transport them, the Organisers will assume the task of organising transportation. In such an event, the cost of the transportation will be borne by the Attendee. This transport may be done by all appropriate means (local vehicle, officials' vehicle, light medical vehicle, ambulance, scheduled flight, ambulance plane) if necessary, under medical surveillance. Only the medical interests of the Attendee and the respect of current health regulations will be considered when choosing the means of transport used. All medical

costs incurred (consultation, medication prescribed by a doctor or a surgeon, medical costs decided by the Organisers), except the medical assistance by any accompanying medical team on the Journey, are the responsibility of the Attendee. Under no circumstances shall the Organisers or JLRIL be held liable for any injury, disability, death, sickness etc., that the Attendee may suffer or be bound to provide any emergency assistance or refund the money.

- The Journey cost does not include costs towards any insurance premium. The Organisers will not obtain any insurance policy covering any risk. The Attendees are advised to seek their own appropriate personal accident/travel insurance coverage as they deem appropriate and at their own cost. All baggage and personal property/s at all times will be at the Attendees' risk and Attendees agree that Organisers will be not be in a position to guard or protect their belongings at any time.

**Refunds & Cancellation:**

- The charges paid will be refunded in case the Attendee's registration is rejected by the Organisers or in case the Journey is cancelled by the Organisers. The charges will not be refunded for any other reason.

- The Client can propose a substitute participant to take her/his place on the Journey.

**Liability:**

- JLRIL or the Organisers shall not be responsible and / or liable for any damages caused to the client due to

circumstances beyond the control of the Organisers or JLRIL (Force Majeure / Vis Major / Acts of God).

- The Organisers shall not be responsible for the temporary or permanent loss of or damage to baggage or personal effects howsoever caused including wilful negligence on the part of any person.

- JLRIL or the Organisers shall not be responsible for any death, personal injury, sickness, accident, loss, delay, discomfort, increased expenses, consequential loss and/or damage or any kind of theft howsoever caused. Force Majeure:
